## WALLPAPER GLUE

## PRODUCT DESCRIPTION

Ready-to-use wallpaper paste

#### APPLICATION

Bonding of vinyl wallpaper up to 370 g/m<sup>2</sup>. Ensures good adhesion of the wallpaper to the substrate. The product is characterised by high adhesion, moisture resistance and high performance.

### SUBSTRATE PREPARATION

The substrate should be smooth, dry, clean and durable. Remove old wallpaper, fill cavities and cracks and level, clean the surface. Particularly absorbent substrates should be primed beforehand.

### PRODUCT PREPARATION

- ✓ Mix the product before use.
- ✓ Do not dilute.
- ✓ Do not mix with other products.

### APPLICATION

Methods: roller, brush

Apply evenly directly to the wall, remove excess adhesive with a sponge or damp cloth. Apply at a temperature of +10°C to +25°C, at a relative humidity of max. 82%, avoid draughts. Once the product has been opened, use it all up. Wash the tools with warm water after use. Wash the painting tools with warm water after use.


### STORAGE AND TRANSPORT
